## Friends of the Canadian Museum for Human Rights celebrates RBC Foundation's \$1 million increase, boosting overall donation to Museum to \$2 million

**Winnipeg, MB** - Two years after Canada became a country in 1867 with the passing of the British North America Act, the Merchants' Bank of Halifax, today known as RBC, received Royal assent from the Parliament of Canada in June 1869. With such deep and pioneering roots in the history and fabric of our country, it was only natural for RBC to be a strong supporter of the Canadian Museum for Human Rights from the early days with an initial gift of \$1 million followed today by an additional \$1 million dollar gift.

"My father, Israel Asper, through his foundation the Asper Foundation, established a national student education program for grade nine students, which teaches them about the Holocaust and human rights," shared Asper. "We realized from talking with the students that they all knew about the Declaration of Independence but, when asked what they knew about Canada's Charter of Rights and Freedoms, it appeared they knew very little. It was then and there that we realized we needed to create a new Canadian institution that would celebrate Canada's history of human rights achievements and we were very firm that there had to be a gallery that profiled the Charter of Rights and Freedoms. This gallery now exists and is generously supported by RBC."

Gail Asper further comments on one of the many inspired goals of the museum. "I'm really hopeful that we can make a difference in this troubled world by transforming indifferent bystanders into human rights heroes and champions."

RBC proudly shares in this goal as well through its donation and support of the Canadian Museum for Human Rights. With this additional \$1 million gift, Friends has raised \$147 million in its private sector capital campaign.
