Our Non-Cumulative First Preferred Shares Series AG (the "**Series AG Preferred Shares**") will be entitled to fixed non-cumulative preferential cash dividends, payable quarterly on the 24th day of February, May, August and November in each year, commencing August 24, 2007, as and when declared by our board of directors, at a quarterly rate of \$0.28125 per share. The initial dividend, if declared, will be payable on August 24, 2007 and will be \$0.369863 per share, based on an anticipated issue date of April 26, 2007.

Subject to the provisions of the *Bank Act* (Canada) (the "**Bank Act**") and the consent of the Superintendent of Financial Institutions Canada (the "**Superintendent**"), on and after May 24, 2012, we may redeem the Series AG Preferred Shares in whole or in part by the payment in cash of a sum equal to \$25.00 per share plus, if redeemed before May 24, 2016, a premium, together with declared and unpaid dividends to the date fixed for redemption. See "Description of the Series AG Preferred Shares".

The Toronto Stock Exchange (the "TSX") has conditionally approved the listing of the Series AG Preferred Shares subject to our fulfilling all of the TSX requirements on or before July 13, 2007.

A purchaser of Series AG Preferred Shares will receive only a customer confirmation from a registered dealer who is a CDS participant and from or through whom the Series AG Preferred Shares are purchased. All dollar amounts referred to in this prospectus supplement are expressed in Canadian dollars unless otherwise specifically expressed.

- (c) our management proxy circular dated January 10, 2007 for our annual meeting of common shareholders held on March 2, 2007; and

Any statement so modified or superseded will not be deemed, except as so modified or superseded, to constitute a part of this prospectus supplement.

# **Use of Proceeds**

The net proceeds to us from the sale of the Series AG Preferred Shares, after deducting estimated expenses of the issue and the underwriters' fee, will be approximately \$242,150,000 (assuming the underwriters' fee is \$0.75 for all Series AG Preferred Shares sold). The proceeds will be added to our general funds and will be used for general business purposes including investment in subsidiaries of the Bank.

## **Share Capital and Subordinated Debentures**

As at January 31, 2007, we had 1,275,949,848 common shares, 76,000,000 first preferred shares and no second preferred shares outstanding.

Our interest requirements on subordinated debentures amounted to \$520 million for the 12 months ended October 31, 2006 and \$499 million for the 12 months ended January 31, 2007. Our dividend requirements on our outstanding first preferred shares, after giving effect to the issue of the Series AG Preferred Shares, adjusted to a before-tax equivalent using an effective income tax rate of 34.6%, amounted to \$122 million for the 12 months ended October 31, 2006 and \$131 million for the 12 months ended January 31, 2007. Our earnings before interest expense and income tax for the 12 months ended October 31, 2006 were \$6,633 million, 10.0 times our aggregate dividend and interest requirements for the period. Our earnings before interest expense and income tax for the 12 months ended January 31, 2007 were \$7,039 million, 10.8 times our aggregate dividend and interest requirements for the period.

In calculating the dividend and interest coverages, foreign currency amounts have been converted to Canadian dollars using the rates of exchange as at the end of each month. For the 12 months ended January 31, 2007, the average exchange rate was Cdn.\$1.1336 per U.S.\$1.00. For the 12 months ended October 31, 2006, the average exchange rate was Cdn.\$1.1325 per U.S.\$1.00.

## **Description of the Series AG Preferred Shares**

The Series AG Preferred Shares will be issued as a series of first preferred shares of the Bank. See the description of our first preferred shares as a class under "Description of the Securities that May be Offered under this Prospectus – First Preferred Shares" in the prospectus.

#### Provisions of the Series AG Preferred Shares as a Series

Issue Price

The Series AG Preferred Shares will have an issue price of \$25.00 per share.

Dividends

The holders of Series AG Preferred Shares will be entitled to receive fixed non-cumulative preferential cash dividends, as and when declared by our board of directors, and subject to the provisions of the Bank Act, payable quarterly on the 24<sup>th</sup> day of February, May, August and November in each year, commencing August 24, 2007, at a quarterly rate of \$0.28125 per share. The first such dividend, if declared, will be paid on August 24, 2007 and, assuming an issue date of April 26, 2007, will amount to \$0.369863 per share.

If our board of directors does not declare any dividend or part thereof on the Series AG Preferred Shares on or before the dividend payment date for a particular quarter, then the right of the holders of the Series AG Preferred Shares to such dividend or part thereof for such quarter will be extinguished.

We are restricted under the Bank Act from paying dividends on the Series AG Preferred Shares in certain circumstances. See "Bank Act Restrictions" in the prospectus.

## Redemption

The Series AG Preferred Shares will not be redeemable prior to May 24, 2012. Subject to the provisions of the Bank Act (see "Bank Act Restrictions" in the prospectus), the provisions described below under "-Restrictions on Dividends and Retirement of Shares" and the consent of the Superintendent, on and after May 24, 2012 we may redeem all or, from time to time, any part of the outstanding Series AG Preferred Shares, at our option, by the payment of an amount in cash for each share redeemed of \$26.00 if redeemed during the 12 months commencing May 24, 2012, \$25.75 per share if redeemed during the 12 months commencing May 24, 2014, \$25.25 per share if redeemed during the 12 months commencing May 24, 2015, and \$25.00 per share commencing May 24, 2016 and thereafter, in each case together with declared and unpaid dividends to, but excluding, the redemption date.

We will give notice of any redemption to registered holders not more than 60 days and not less than 30 days prior to the redemption date.

Where a part only of the then outstanding Series AG Preferred Shares is at any time to be redeemed, the Series AG Preferred Shares will be redeemed *pro rata* disregarding fractions, or in such other manner as our Board of Directors determines.

Conversion into Another Series of Preferred Shares at the Option of the Holder

We may, at any time by resolution of our board of directors, constitute a further series of first preferred shares ("New Preferred Shares") having rights, privileges, restrictions and conditions attaching thereto which would qualify such New Preferred Shares as Tier 1 capital of the Bank under the then current capital adequacy guidelines prescribed by the Superintendent. We will ensure that such New Preferred Shares will not, if issued, be or be deemed to be "term preferred shares" or "short-term preferred shares" within the meaning of the *Income Tax Act* (Canada) (the "Tax Act"). In such event, we may, with the consent of the Superintendent, give registered holders of the Series AG Preferred Shares notice that they have the right, pursuant to the terms of the Series AG Preferred Shares, at their option, to convert their Series AG Preferred Shares on the date specified in the notice into fully-paid and non-assessable New Preferred Shares on a share for share basis. We will give notice to registered holders not more than 60 days and not less than 30 days prior to the conversion date. See "Bank Act Restrictions" in the prospectus.

## Purchase for Cancellation

Subject to the provisions of the Bank Act, the provisions described below under "-Restrictions on Dividends and Retirement of Shares" and the consent of the Superintendent, we may at any time, by private contract or in the market or by tender, purchase for cancellation any Series AG Preferred Shares at the lowest price or prices at which in the opinion of our board of directors such shares are obtainable.

## Rights on Liquidation

In the event of our liquidation, dissolution or winding-up, the holders of the Series AG Preferred Shares will be entitled to receive \$25.00 per share, together with all dividends declared and unpaid to the date of payment, before any amount may be paid or any or our assets distributed to the registered holders of any shares ranking junior to the Series AG Preferred Shares. The holders of the Series AG Preferred Shares will not be entitled to share in any further distribution of our assets.

## Restrictions on Dividends and Retirement of Shares

So long as any of the Series AG Preferred Shares are outstanding, we will not, without the approval of the holders of the Series AG Preferred Shares:

- pay any dividends on any second preferred shares, any common shares or any other shares ranking junior to the Series AG Preferred Shares (other than stock dividends in any shares ranking junior to the Series AG Preferred Shares); or
- redeem, purchase or otherwise retire any second preferred shares, any common shares or any other shares ranking junior to the Series AG Preferred Shares (except out of the net cash proceeds of a substantially concurrent issue of shares ranking junior to the Series AG Preferred Shares); or
- redeem, purchase or otherwise retire less than all the Series AG Preferred Shares; or
- except pursuant to any purchase obligation, sinking fund, retraction privilege or mandatory redemption provision attaching to any series of preferred shares, redeem, purchase, or otherwise retire any other shares ranking on a parity with the Series AG Preferred Shares;

unless all dividends up to and including the dividend payment date for the last completed period for which dividends are payable have been declared and paid, or set apart for payment, in respect of each series of cumulative first preferred shares then issued and outstanding and all other cumulative shares ranking on a parity with the first preferred shares and we have paid, or set apart for payment, all declared dividends in respect of each series of non-cumulative first preferred shares (including the Series AG Preferred Shares) then issued and outstanding, and on all other non-cumulative shares ranking on a parity with the first preferred shares. See "Bank Act Restrictions" in the prospectus.

#### Issue of Additional Series of First Preferred Shares

We may issue other series of first preferred shares ranking on a parity with the Series AG Preferred Shares without the approval of the holders of the Series AG Preferred Shares as a series.

## Amendments to the Series AG Preferred Shares

We will not without, but may from time to time with, the approval of the holders of the Series AG Preferred Shares given as specified below and any approval of the TSX as may be necessary, delete, add to or vary any rights, privileges, restrictions or conditions attaching to the Series AG Preferred Shares. In addition, we will not without, but may from time to time with, the consent of the Superintendent, make any such deletion, addition or variation which might affect the classification afforded the Series AG Preferred Shares from time to time for capital adequacy requirements pursuant to the Bank Act and the regulations and guidelines thereunder.

## Shareholder Approvals

The approval of all amendments to the rights, privileges, restrictions and conditions attaching to the Series AG Preferred Shares as a series and any other approval to be given by the holders of the Series AG Preferred Shares may be given in writing by the holders of not less than all of the outstanding Series AG Preferred Shares or by a resolution carried by the affirmative vote of not less than 66 2/3% of the votes cast at a meeting of holders of the Series AG Preferred Shares at which

a quorum of the outstanding Series AG Preferred Shares is represented. Pursuant to our by-laws, a quorum at any meeting of the holders of Series AG Preferred Shares is 51% of the shares entitled to vote at any such meeting, except that at a reconvened meeting following a meeting which was adjourned due to lack of quorum, there is no quorum requirement. At any meeting of holders of Series AG Preferred Shares as a series, each such holder will be entitled to one vote in respect of each Series AG Preferred Share held.

#### Voting Rights

Subject to the provisions of the Bank Act, the holders of the Series AG Preferred Shares as such will not be entitled to receive notice of, or to attend or to vote at, any meeting of our shareholders unless and until the first time at which the rights of such holders to any undeclared dividends have been extinguished as described under "-Dividends" above. In that event, the holders of the Series AG Preferred Shares will be entitled to receive notice of, and to attend, meetings of shareholders at which directors are to be elected and will be entitled to one vote for each share held. The voting rights of the holders of the Series AG Preferred Shares will forthwith cease upon payment by us of the first quarterly dividend on the Series AG Preferred Shares to which the holders are entitled subsequent to the time such voting rights first arose. At such time as the rights of such holders to any undeclared dividends on the Series AG Preferred Shares have again been extinguished, such voting rights will become effective again and so on from time to time.

#### **Book-Entry Only Issue**

Except in limited circumstances, the Series AG Preferred Shares will be issued in "book entry only" form and must be purchased or transferred through financial institutions that participate in the depository service of CDS. See "Book-Entry Only Securities" in the prospectus.

#### **Canadian Federal Income Tax Considerations**

The following summary describes the principal Canadian federal income tax considerations generally applicable to a purchaser of Series AG Preferred Shares pursuant to this prospectus supplement who, for the purposes of the Tax Act and the regulations thereunder (the "Regulations"), is resident at all relevant times in Canada or deemed to be a resident of Canada, deals at arm's length with us, is not affiliated with us, and holds such shares as capital property (a "holder"). Generally, the Series AG Preferred Shares will be capital property to a holder provided the holder does not acquire the Series AG Preferred Shares in the course of carrying on a business of trading or dealing in securities or as part of an adventure or concern in the nature of trade. Certain holders whose Series AG Preferred Shares would not otherwise qualify as capital property may, in certain circumstances, be entitled to have the Series AG Preferred Shares and all other "Canadian securities", as defined in the Tax Act, treated as capital property by making the irrevocable election permitted by subsection 39(4) of the Tax Act. This summary is not applicable to a purchaser an interest in which is a "tax shelter investment", as defined in the Tax Act, or to a purchaser who is a "financial institution" for purposes of certain rules applicable to securities held by financial institutions (referred to as the "mark-to-market" rules), as defined in the Tax Act. Such purchasers should consult their own tax advisors. Furthermore, this summary is not applicable to an investor that is a specified financial institution (as defined in the Tax Act) that receives (or is deemed to receive), alone or together with persons with whom it does not deal at arm's length, in the aggregate dividends in respect of more than 10% of the Series AG Preferred Shares outstanding at the time the dividend is received. This summary also assumes that all issued and outstanding Series AG Preferred Shares are listed on a prescribed stock exchange in Canada (as defined in the Tax Act) at such times as dividends (including deemed dividends) are paid or received on such shares.

This summary is based upon the current provisions of the Tax Act and the Regulations, and the Bank's Canadian legal counsel's understanding of the current published administrative and assessing policies of the Canada Revenue Agency. This summary takes into account all specific proposals to amend the Tax Act and Regulations publicly announced by or on behalf of the Minister of Finance (Canada) prior to the date hereof (the "Tax Proposals") and assumes that all Tax Proposals will be enacted in the form proposed. However, no assurances can be given that the Tax Proposals will be enacted as proposed, or at all. This summary does not otherwise take into account or anticipate any changes in law or administrative or assessing practice, whether by legislative, regulatory, administrative or judicial action, nor does it take into account provincial, territorial or foreign tax considerations which may differ from those discussed herein.

This summary is of a general nature only and is not, and is not intended to be, legal or tax advice to any particular holder and no representation with respect to the income tax consequences of any particular holder is made. This summary is not exhaustive of all federal income tax considerations. Accordingly, prospective purchasers of Series AG Preferred Shares should consult their own tax advisors with respect to their particular circumstances.

#### Dividends

Dividends (including deemed dividends) received on the Series AG Preferred Shares by an individual (other than certain trusts) will be included in the individual's income and will be subject to the gross-up and dividend tax credit rules normally applicable to taxable dividends received from taxable Canadian corporations. In certain circumstances, such shareholders will be entitled to an enhanced dividend tax credit in respect of "eligible dividends" paid after 2005. Eligible dividends generally include dividends received from public corporations resident in Canada to the extent such corporations have business income subject to the general corporate tax rate. We will notify shareholders, in accordance with the Tax Act, of the extent to which dividends on the Series AG Preferred Shares are eligible dividends. Dividends (including deemed dividends) on the Series AG Preferred Shares received by a corporation will be included in computing the corporation's income and will generally be deductible in computing the taxable income of the corporation.

The Series AG Preferred Shares will be "taxable preferred shares" as defined in the Tax Act. The terms of the Series AG Preferred Shares require us to make the necessary election under Part VI.1 of the Tax Act so that corporate investors will not be subject to tax under Part IV.1 of the Tax Act on dividends paid (or deemed to be paid) by us on the Series AG Preferred Shares.

A private corporation, as defined in the Tax Act, or any other corporation controlled, whether by reason of a beneficial interest in one or more trusts or otherwise, by or for the benefit of an individual (other than a trust) or a related group of individuals (other than trusts), will generally be liable to pay a 33½% refundable tax under Part IV of the Tax Act on dividends received (or deemed to be received) on the Series AG Preferred Shares to the extent such dividends are deductible in computing its taxable income.

## Dispositions

A holder who disposes of or is deemed to dispose of Series AG Preferred Shares (either on redemption of the shares for cash or otherwise, but not on conversion) will generally realize a capital gain (or sustain a capital loss) to the extent that the proceeds of disposition, net of any reasonable costs of disposition, exceed (or are less than) the adjusted cost base of such shares to that holder. The amount of any deemed dividend arising on the redemption or purchase for cancellation by the Bank of Series AG Preferred Shares will not be included in computing the proceeds of disposition to any shareholder for purposes of computing the capital gain or capital loss arising on the disposition of the Series AG Preferred Shares. See "Redemption" below.

Generally, one-half of a capital gain will be included in computing the holder's income as a taxable capital gain and one-half of a capital loss may be deducted from the holder's taxable capital gains in accordance with the rules contained in the Tax Act. Taxable capital gains of a Canadian-controlled private corporation may be subject to an additional refundable tax of 6½3% of such taxable gains. Capital gains realized by an individual may give rise to alternative minimum tax under the Tax Act. A capital loss may in certain circumstances be reduced by the amount of any dividends, including deemed dividends, which have been received on such shares.

# Redemption

If we redeem Series AG Preferred Shares for cash or otherwise acquire Series AG Preferred Shares other than by a purchase in the manner in which shares are normally purchased by a member of the public in the open market, the holder will be deemed to have received a dividend equal to the amount, if any, paid by us in excess of the paid-up capital of such shares at such time. The difference between the amount paid and the amount of the deemed dividend will be treated as proceeds of disposition for the purposes of computing the capital gain or capital loss arising on the disposition of such shares. See "Dispositions" above. In the case of a corporate holder, it is possible that in certain circumstances all or part of the amount so deemed to be a dividend may be treated as proceeds of disposition and not as a dividend.

## Conversion

The conversion of the Series AG Preferred Shares into New Preferred Shares will be deemed not to be a disposition of property and accordingly will not give rise to any capital gain or capital loss. The cost to a holder of New Preferred Shares received on the conversion will be deemed to be equal to the holder's adjusted cost base of the Series AG Preferred Shares immediately before the conversion.

## **Ratings**

The Series AG Preferred Shares are provisionally rated "Pfd-1" by DBRS Limited ("**DBRS**"). "Pfd-1" is in the highest category available from DBRS for preferred shares. A reference to "high" or "low" reflects the relative strength within the rating category.

The Series AG Preferred Shares are provisionally rated "P-1(low)" by Standard & Poor's ("**S&P**") using the S&P Canadian scale for preferred shares and "A" using S&P's global scale for preferred shares. The "P-1" rating is in the highest of the five categories used by S&P on its Canadian preferred share scale. A reference to "high" or "low" reflects the relative strength within the rating category. The "A" rating is in the highest of the three categories used by S&P on its global scale.

The Series AG Preferred Shares are provisionally rated "Aa2" by Moody's Investors Service. Securities rated "Aa" are considered high quality and subject to very low credit risk. The modifier "2" indicates that the obligation ranks in the midrange of the "Aa" rating category.

Prospective purchasers of Series AG Preferred Shares should consult the relevant rating organization with respect to the interpretation and implications of the foregoing provisional ratings. The foregoing ratings should not be construed as recommendations to buy, sell or hold Series AG Preferred Shares. Ratings may be revised or withdrawn at any time by the respective rating organizations.

#### **Plan of Distribution**

Pursuant to an underwriting agreement dated April 18, 2007, we have agreed to sell and the underwriters have severally agreed to purchase on April 26, 2007, or such date as may be agreed upon, but not later than May 30, 2007, subject to the terms and conditions stated in the underwriting agreement, all but not less than 10,000,000 Series AG Preferred Shares at a price of \$25.00 per share, payable in cash to the Bank against delivery of such Series AG Preferred Shares. The obligations of the underwriters under the underwriting agreement may be terminated at their discretion upon the occurrence of certain stated events. The underwriters are, however, obligated to take up and pay for all of the Series AG Preferred Shares if any are purchased under the underwriting agreement.

The underwriting agreement provides that the underwriters will be paid a fee per share equal to \$0.25 for each Series AG Preferred Share sold to certain institutions and \$0.75 for all other Series AG Preferred Shares sold.

Pursuant to policy statements of certain securities regulators, the underwriters may not, throughout the period of distribution, bid for or purchase any Series AG Preferred Shares. The policy statements allow certain exceptions to the foregoing prohibitions. The underwriters may only avail themselves of such exceptions on the condition that the bid or purchase not be engaged in for the purpose of creating actual or apparent active trading in, or raising the price of, the Series AG Preferred Shares. These exceptions include a bid or purchase permitted under the Universal Market Integrity Rules for Canadian Marketplaces of Market Regulation Services Inc., relating to market stabilization and passive market making activities and a bid or purchase made for and on behalf of a customer where the order was not solicited during the period of distribution. Subject to the foregoing, in connection with this offering, the underwriters may over-allot or effect transactions which stabilize or maintain the market price of the Series AG Preferred Shares at levels other than those which otherwise might prevail on the open market. Such transactions, if commenced, may be discontinued at any time.

Pursuant to an Ontario securities rule, the underwriters may not, beginning two days prior to the date that the offering price was determined and throughout the period of distribution of the Series AG Preferred Shares (the "Restricted Period"), bid for or purchase Series AG Preferred Shares. The foregoing restriction is subject to certain exceptions. These exceptions include a bid or purchase permitted under the by-laws and rules of the TSX relating to market stabilization and passive market-making activities, provided that the bid or purchase does not exceed the lesser of the offering price and the last independent sale price at the time of the entry of the bid or order to purchase, and a bid or purchase made for and on behalf of a customer where the order was not solicited during the period of distribution, provided that the bid or purchase not be engaged in for the purpose of creating actual or apparent active trading in, or raising the price of, the Series AG Preferred Shares. Pursuant to the first mentioned exception, in connection with this offering, the underwriters may over-allot or effect transactions that stabilize or maintain the market price of the Series AG Preferred Shares at levels other than those which might otherwise prevail on the open market. Such transactions, if commenced, may be discontinued at any time.

We indirectly wholly-own RBC Dominion Securities Inc., one of the underwriters. We are a related and connected issuer of RBC Dominion Securities Inc. under applicable securities legislation. The decision to distribute the Series AG Preferred Shares and the determination of the terms of this offering were made through negotiations between us on the one hand and

the underwriters on the other. BMO Nesbitt Burns Inc., an underwriter, in respect of which the Bank is not a related or connected issuer, has participated in the structuring and pricing of the offering and in the due diligence activities performed by the underwriters for the offering. RBC Dominion Securities Inc. will not receive any benefit from us in connection with this offering other than a portion of the underwriters' fee.

## **Eligibility for Investment**

In the opinion of our counsel, Ogilvy Renault LLP, and in the opinion of the underwriters' counsel, Stikeman Elliott LLP, the Series AG Preferred Shares, if issued on the date of this prospectus supplement, would be qualified investments under the Tax Act and the Regulations thereunder for trusts governed by registered retirement savings plans, registered retirement income funds, registered education savings plans, and deferred profit sharing plans.

# **Transfer Agent and Registrar**

Computershare Trust Company of Canada at its offices in the cities of Toronto, Montreal, Halifax, Winnipeg, Calgary and Vancouver will be the transfer agent and registrar for the Series AG Preferred Shares.

#### **Risk Factors**

An investment in the Series AG Preferred Shares is subject to certain risks including those set out in the prospectus and the following:

The value of the Series AG Preferred Shares will be affected by our general creditworthiness. Our management's discussions and analyses for the year ended October 31, 2006 and for the three months ended January 31, 2007 are incorporated by reference. Such analyses discuss, among other things, known material trends and events, and risks or uncertainties that are reasonably expected to have a material effect on our business, financial condition or results of operations.

See "Share Capital and Subordinated Debentures" and "Earnings Coverage", which are relevant to an assessment of the risk that we will be unable to pay dividends and any redemption price on the Series AG Preferred Shares when due.

We have covenanted that if a distribution is not paid when due on any outstanding RBC Trust Capital Securities (also known as "**RBC TruCS**") issued by RBC Capital Trust or RBC Capital Trust II, we will not pay dividends on our outstanding preferred or common shares, which would include the Series AG Preferred Shares, for a specified period of time unless the required distribution is paid to the holders of RBC TruCS.

The redemption of the Series AG Preferred Shares is subject to the consent of the Superintendent and other restrictions contained in the Bank Act. See "Bank Act Restrictions" in the prospectus and "Description of the Series AG Preferred Shares - Provisions of the Series AG Preferred Shares as a Series - Restrictions on Dividends and Retirement of Shares" in this prospectus supplement.

## **Legal Matters**

The matters referred to under "Canadian Federal Income Tax Considerations" and certain other legal matters relating to this offering will be passed upon by Ogilvy Renault LLP on our behalf and Stikeman Elliott LLP on behalf of the underwriters.

As at April 17, 2007, the partners and associates of each of Ogilvy Renault LLP and Stikeman Elliott LLP beneficially owned, directly or indirectly, less than 1% of the issued and outstanding securities of the Bank or of any associate or affiliate of the Bank.
