### A Message from the KIT Team

Dear RBC Pensioner,

We always appreciate hearing from you, our readers. We enjoy learning about your activities and second careers, and don't even mind when you correct us! This issue is a case in point.

Doug Williamson and Frank Moore both wrote about how their post-RBC interests have taken them to places they never imagined. We found their stories inspiring and hope you feel the same way.

We also heard from Fran Banks in July, about RBC pensioners in BC who were volunteering with wildfire relief: "You may not know about the role they are playing. Fellow pensioners that I'm aware of -- and I know these few are only the tip of the iceberg -- are working from 7 a.m. to 11 p.m. Sandra Dever wrote on Facebook the other day that she had received a call that a new group of evacuees had arrived and she went back to the evacuation centre at 2 a.m. after being home for only a couple of hours."

Newly retired Mara Pavan of Kamloops also wrote on Facebook: "It's been very rewarding volunteering at the Sandman Center registering evacuees. So thankful for the time to help out. It has been amazing seeing fellow coworkers from RBC and friends....very emotional. Anyways be thankful for all the blessings you have."

We thank Fran for bringing these comments and the selfless efforts of pensioners, to our attention.

(In July, RBC donated \$50,000 to the Canadian Red Cross in support of those affected by the BC wildfires.)

Now for that correction: Ken Gillis was surprised with the RBC Corporate Archive feature in issue 2, 2017. We implied that RBC pre-dated Canada's confederation, thanks to our 1864 origins with Merchants Bank in Halifax. Yet Ken recalls celebrating a 125th anniversary at RBC in 1992. The math didn't add up. We took the discrepancy to RBC Corporate Archives and here's the response: "RBC celebrated Canada's 125th in 1992. RBC celebrated its own 125th anniversary in 1994. While we began in 1864, RBC celebrates its anniversary based on its date of incorporation, which was 1869. Therefore, we will be celebrating our 150th anniversary in 2019." So Ken, we're both a little right and a little wrong. But we look forward to seeing how RBC will celebrate its century-and-a-half in just a couple of years.

Here are some highlights from the RBC third quarter results of 2017.

### Pay bills through Siri – a Canadian first

RBC clients are now the first in Canada who can ask Siri to pay their bills on iPhone and iPad. Personal & Commercial Banking also launched seamless Interac e-Transfer payments within iMessage, which lets clients send a transfer without leaving their iMessage window. By offering services through Siri and iMessage, we're providing more convenient solutions to support our client's payment needs and delivering value in the channels they use.

#### From Amplify to consumers

RBC Insurance launched an innovative new mobile travel app called PATH. With geolocation functionality, PATH can help travelers find emergency assistance or medical facilities in a foreign country, get up-to-date travel advisories and send automated emails to family and friends, using a mobile or tablet device. The idea was conceived by a 2016 Amplify student innovation team and was developed by T&O and business reps in an agile lab in just 5 months. It has a 4.7/5 rating on Google Play!



### Capital Markets Trades for the Kids across North America

RBC Capital Markets hosted the first ever RBC Trade for the Kids North America this quarter, raising \$2 million in support of youth-focused initiatives. Global

Markets trading floors across Canada and the U.S., alongside I&TS Treasury & Market Services colleagues in Toronto, united to raise funds in support of 16 different charities. First launched in New York in 2015 and expanded to London earlier this year, RBC Trade for the Kids will become a one-day, 24-hour global fundraising event next year, leveraging our investment banking division's international strength and its longstanding commitment to helping communities prosper.

### A Suitcase Carries Precious Memories

A suitcase, seven mothers and a junior Royal Bank clerk. What could they possibly have in common? Frank Moore solved the puzzle and in doing so, has helped bring history to life.



The story of the puzzle is closely linked to Frank's lifelong interest in military history. As a teenager, he attended cadets then army camp and would have enlisted if a career with RBC hadn't been so tempting. He pursued his interests though, often travelling to Europe for battlefield tours. Then in 2013, he made a discovery that would determine his direction for years to come when he acquired a brown suitcase, the size of a laptop.

"The suitcase had been in the McCracken family's basement in Montreal but they had no descendants," explains Frank. "When I learned the contents were going to be separated and sold online, I bought the whole thing." The contents that affected Frank so deeply were pictures and letters collected by the mother of Alex McCracken, R.C.A.F. who at age 21, was reported missing in action with his crew, over Ten Boer, Holland, on July 25, 1943.

The painting by artist Doug Bradford, is based on the testimony of the German major who shot down the plane.

"When I first read the letters, I was devastated," Frank recalls. "It took nine months for the families to learn that all the men had died except for one who survived by parachuting from the Halifax bomber. He was taken prisoner by the Germans." One letter, with the sad news notifying the families, was from the casualty officer who provided names and addresses of the crew's next of kin. It was Catherine McCracken – Alex's mother and owner of the suitcase – who began corresponding with the other mothers. Thirty letters tell the story, with the first being a letter of condolence to Catherine from another mother, dated November 1943.

Early in his research, Frank learned that before enlisting, Alex had been an RBC junior clerk and teller, in Montreal. "I started my career the same way," says Frank, "but he wasn't able to fulfill his life goals the way I was. I could relate to him, absolutely." So in April 2016, Frank felt privileged to participate in a ceremony in Ten Boer, attended by many townspeople. He brought with him

attended by many townspeople. He brought with him the letters, Alex's medals, and a painting for the mayor. Frank also presented an album he's created documenting the letters, how he found the suitcase, and pictures including the crew, aircraft, and Ten Boer site where the plane was shot down. The ceremony attracted Canadian and international media attention.

For Frank, the suitcase and the events it has inspired represent the pinnacle of his military-related pursuits. "It is one of the most touching and satisfying experiences I've ever had," admits Frank. "It's so important to honour these men and never forget them."

### A Study of Life's Lessons on the French Riviera

"Almost everything written on retirement is about the joys awaiting you when your work days are over. As helpful as that may be, there is another side to the story." So began Doug Williamson's initial correspondence with *Keeping in Touch*.

The "side" that Doug was referring to is about recovering from grief. Eleven years have passed since Effie, his wife of 55 years, has died. Since then, Doug has discovered that there is still plenty of life to embrace and many lessons left to learn.

Ultimately, Doug's story is a happy one. The retiree, who has been receiving a pay or pension cheque from RBC without interruption for 70 years, may hold the record for that distinction. "I have been one lucky guy," admits Doug. "But when I was widowed at 76 years-old I had no idea of how to take care of myself."

Grief counselling, which Doug initially resisted, helped him regain a more positive outlook, as did a lecture about loss, at the University of British Columbia. "Most of the participants were young and I realized we all suffer losses." That lecture motivated Doug to reconnect with his estranged son, and today they enjoy a renewed and close relationship. A new life lesson about forgiveness was added to his repertoire and he thought, "What else could be in store for me?"

The answer came in 2007 when Doug enrolled in a month-long, intensive French language studies program in Villefranche-sur-Mer, on the French Riviera. Doug had read about *l'Institut de Français* in a newspaper article and it appealed to his long-time desire to learn the language. For eight years, Doug attended the course annually and gradually, he moved from an intermediate to advanced level. Now, he can carry on a conversation with ease. "Beginning last year, I started taking private lessons with the first professor I had. We spend 90 minutes in my apartment then walk to the seaside for another 90 minutes, three times a week during the month I'm there," describes Doug. "I thought learning French in France would help me recover from my wife's death. Now I continue because it's very good for me and the south of France isn't bad, either!"

Well into his eighties, Doug – known as "Dooglas" to his French teachers and friends – is still discovering important life lessons. Not only has he learned that age doesn't have to be an impediment to learning and retaining knowledge, he's developed new qualities. "I'm a more social person now. Mixing with students from all over the world and from every profession means I'm not as judgmental. This experience has made me a better person."

Recently, Doug and daughter Melinda Seale (also an RBC pensioner), were invited to the Royal Centre in Vancouver, BC for a lunch in honour of Doug's unique 70-year record. As for the foreseeable future, Doug plans to continue his annual trips to France, to hone his language skills and perhaps earn another honour – most senior student on the French Riviera.

### Message from the Chair of the Pension Plan Management Committee

As RBC takes action to position ourselves for the future, there will be many contributors to our success, but none more important than you. Part of this is planning and saving for your future. The RBC Retirement & Savings Programs have many features that are designed to help you reach your financial goals. The Pension Plan Management Committee (PPMC) helps protect the interests of RBC pension plan members by ensuring that the pension plans have a strong governance and compliance structure in place.

#### Performance of the Defined Benefit (DB) Plan

The funded status of the DB plan in Canada remained sound during 2016 despite a volatile market and the impact of lower bond yields on the discount rate used to determine the plan's liabilities. On a **going-concern** basis<sup>1</sup>, the Royal Bank Pension Plan, our largest plan in Canada, was 115% funded as of January 1, 2017. Measured on a **solvency** basis<sup>2</sup>, the Royal Bank Pension Plan was 92% funded as of January 1, 2017.

The PPMC monitors the assets of the DB plan, ensuring an appropriate level of risk is taken in light of the longterm nature of the plan's obligations (the pensions earned by plan members) while looking for compelling long-term investment returns and opportunities.

For the 2016 calendar year, the plan earned an overall return of **6.4%**, outperforming our benchmark return of **5.8%**. The strong performance was attributed to active management of the plan's investments.

#### Features of the Defined Contribution (DC) Plan

The DC plan includes many features – designed to support plan members with their retirement savings objectives – including both automatic and matching contributions from RBC.

In addition, RBC aims to provide a set of investment choices under the DC plan that enable plan members to construct and maintain a well-diversified investment portfolio, in addition to providing solutions for those who prefer a more "hands-off" investment solution.


- <sup>1</sup> The **going concern** funded status is a measure used to determine the plan's liabilities assuming that both the Royal Bank Pension Plan and RBC continue indefinitely into the future.
- <sup>2</sup> The **solvency** funded status is another measure that is required by pension regulators. It determines the funded status of the DB plan under a hypothetical scenario where the plan is terminated immediately and all benefits are paid to members. Assumptions used to determine the funded status are prescribed by legislation.

**Diversification** is a technique that reduces risk by allocating investments among a variety of financial instruments, industries and other categories. By holding a mix of investments, your portfolio may be cushioned against sudden market swings.

The asset mix policy reflects the plan's long-term investment strategy. As of December 31, 2016, the actual asset mix was within the allowable range of its policy.


