

### Important information for investment accounts

Subject to completion of the sale, by the end of March 2024<sup>†</sup>, you can expect your HSBC investment accounts to migrate and become accounts of (and the applicable agreements assigned to) the RBC businesses listed below:

#### What you need to know

- You can expect your HSBC investment accounts will be transferred to RBC at no cost to you.
- You have the right to close your account(s) with us or transfer them to another firm. Any transfer-out fees will be waived until the migration date.
- If you have an HSBC Private Investment Counsel (Canada) Inc. account or a HSBC Investment Funds (Canada) Inc. account invested in our HSBC World Selection Portfolio® service, please note that if you want to transfer your HSBC Pooled Funds held within these accounts to another firm that is not RBC, you will need to sell your HSBC Pooled Funds and transfer the proceeds in cash.
- If you have a non-registered HSBC Investment Funds (Canada) Inc. account holding cash, you will receive a further communication from us regarding your options for your cash.

# Change of Control for HSBC Global Asset Management (Canada) Limited, the Manager of the HSBC Mutual Funds and HSBC Pooled Funds

This notice is relevant to you if you hold HSBC Mutual Funds and/or HSBC Pooled Funds (the "Funds") in your HSBC account(s).

The sale of HSBC Bank Canada to Royal Bank of Canada constitutes a change of control of HSBC Global Asset Management (Canada) Limited ("AMCA").

AMCA gives notice to you that, on the **Closing Date**<sup>†</sup>, subject to the closing of the sale, there will be a change of control of AMCA. Specifically, AMCA is expected to become a wholly-owned subsidiary of Royal Bank of Canada or an affiliate thereof. In addition, as of the migration date, AMCA is expected to be renamed RBC Indigo Asset Management Inc. by its new parent company and the Funds are expected to be renamed as set out in Schedule "A".

We are providing you with this change of control notice for informational purposes only, further to our obligations under section 5.8 of National Instrument 81-102 – *Investment Funds*. This notice does not require you to take any action. The Simplified Prospectus and Fund Facts for the Funds are available on each Fund's respective SEDAR+ profile at <a href="https://www.sedarplus.ca">www.sedarplus.ca</a>.

Additionally, AMCA hereby gives you notice of the following changes, which are also expected to be effective as of the migration date:

- The period upon which the short-term trading fee applies to the Funds will change from 30 days to 7 days. Amongst other exceptions outlined in the Simplified Prospectus, the short-term trading fee will not apply to any sales or switches of units of the Funds conducted more than 7 days after purchase of those units.
- The HSBC Canadian Money Market Fund, HSBC Canadian Money Market Pooled Fund and the HSBC U.S. Dollar Money Market Fund will make a special distribution if necessary on or around the migration date to pay out interest accrued up to the migration date. The distribution for other Funds that would normally distribute income at the end of March may be paid earlier in the month.

HSBC Global Asset Management (Canada) Limited ("AMCA") is a wholly owned subsidiary of, but separate entity from, HSBC Bank Canada.

AMCA is the manager and primary investment advisor for the HSBC Mutual Funds and the HSBC Pooled Funds (collectively, the "HSBC Funds"). HIFC is the principal distributor of the HSBC Mutual Funds, which are also distributed through authorized dealers. HIFC also offers the HSBC Funds through the HSBC World Selection® Portfolio. This is a portfolio investment service under which client's assets are invested in model portfolios which are comprised of investments in the Funds. AMCA provides discretionary investment management services to the model portfolios in the HSBC World Selection Portfolio service. Commissions, trailing commissions, management fees, investment management fees and expenses all may be associated with investments in the HSBC Funds and/or the HSBC World Selection Portfolio service. Please read the prospectus, Fund Facts, applicable account opening documentation and other disclosure documents before investing in the HSBC Funds and/or the HSBC World Selection Portfolio service.
