This Supplementary Prospectus (the "4th Supplementary Prospectus") to the Base Prospectus dated July 27, 2023, as supplemented by the 1st Supplementary Prospectus dated August 25, 2023, the 2nd Supplementary Prospectus dated December 18, 2023 and the 3rd Supplementary Prospectus dated January 3, 2024 (together, the "Base Prospectus"), and Admission Particulars for Royal Bank of Canada ("RBC" or the "Issuer") constitutes a supplementary prospectus in respect of the Base Prospectus for the Issuer for the purposes of Article 23.1 of the U.K. Prospectus Regulation and supplementary admission particulars in respect of the Admission Particulars for the purposes of the ISM Rulebook, and is prepared in connection with the €75,000,000,000 Global Covered Bond Programme of Royal Bank of Canada, unconditionally and irrevocably guaranteed as to payments by RBC Covered Bond Guarantor Limited Partnership (the "Guarantor LP"), established by RBC (the "Programme"). When used in this 4th Supplementary Prospectus, "U.K. Prospectus Regulation" means Regulation (EU) 2017/1129 as it forms part of U.K. domestic law by virtue of the European Union (Withdrawal) Act 2018, as amended.

Terms defined in the Base Prospectus have the same meaning when used in this  $4^{th}$  Supplementary Prospectus. This  $4^{th}$  Supplementary Prospectus is supplemental to, and shall be read in conjunction with, the Base Prospectus.

RBC and the Guarantor LP accept responsibility for the information contained in this 4<sup>th</sup> Supplementary Prospectus. To the best of the knowledge of RBC and the Guarantor LP, the information contained in this 4<sup>th</sup> Supplementary Prospectus is in accordance with the facts and this 4<sup>th</sup> Supplementary Prospectus makes no omission likely to affect its import.

The purpose of this 4<sup>th</sup> Supplementary Prospectus is to (a) incorporate by reference in the Base Prospectus the Issuer's unaudited interim condensed consolidated financial statements (the "First Quarter 2024 Unaudited Interim Condensed Consolidated Financial Statements"), together with Management's Discussion and Analysis (the "First Quarter 2024 MD&A"), for the three-month period ended January 31, 2024 set out in the Issuer's First Quarter 2024 Report to Shareholders (the "First Quarter 2024 Report to Shareholders"); (b) incorporate by reference in the Base Prospectus the Investor Report for the calculation date of January 31, 2024 (the "January Investor Report"); (c) update the link to the Issuer's website page maintained in respect of the Programme; (d) include an updated statement in respect of no significant change; and (e) update paragraph 3 of the section entitled "GENERAL INFORMATION" in the Base Prospectus regarding governmental, legal or arbitration proceedings which may have, or have had, a significant effect on the financial position or profitability of the Issuer or of the Issuer and its subsidiaries taken as a whole.

To the extent that there is any inconsistency between (a) any statement in this 4<sup>th</sup> Supplementary Prospectus or any statement incorporated by reference into the Base Prospectus by this 4<sup>th</sup> Supplementary Prospectus; and (b) any other statement in, or incorporated by reference in, the Base Prospectus, the statements referenced in (a) above will prevail.

Save as disclosed in this 4<sup>th</sup> Supplementary Prospectus or those sections of the First Quarter 2024 Report to Shareholders incorporated by reference in the Base Prospectus by virtue of this 4<sup>th</sup> Supplementary Prospectus, no significant new factor, material mistake or material inaccuracy relating to the information included in the Base Prospectus which may affect the assessment of Covered Bonds issued under the Programme has arisen or been noted, as the case may be, since approval by the Financial Conduct Authority (the "**FCA**") of the 3<sup>rd</sup> Supplementary Prospectus dated January 3, 2024.
