This document constitutes the Pricing Supplement for the Notes described herein. This document must be read in conjunction with the Structured Securities Base Prospectus dated 30 July 2021 as supplemented by the supplements dated 3 September 2021, 22 December 2021 and 2 March 2022 (the "**Base Prospectus**").
